The BAC shall have the following functions in accordance with Rule V, Section 12 of the 2016 RIRR of RA 9184: advertise and/or post the invitation to bid; conduct pre-procurement and pre-bid conferences; determine the eligibility of prospective bidders; receive and open bids; conduct the evaluation of bids; undertake post-qualification proceedings; resolve requests for reconsideration; recommend award of contracts to the Head of the Procuring Entity (HoPE) or his duly authorized representative and perform such other related functions as may be necessary, including the creation of a Technical Working Group (TWG) from a pool of technical, financial, and/or legal experts to assist in the procurement process.


The BAC shall be responsible for ensuring the Procuring Entity abides by the standards set forth by RA 9184 and its IRR, and it shall prepare a procurement monitoring report that shall be approved and submitted by the Procuring Entity to the GPPB.

Section 11.2.3 of the 2016 RIRR of RA 9184 provides that alternate members of the BAR, designated by the HoPE, and with the same qualifications as that of the original members designated under Section 11.2.2 of the 2016 IRR, shall attend meetings of the BAC and receive the proportionate honoraria, whenever the original members are absent.

The Secretariat shall act as central channel of communications, provide administrative support to the BAC and TWG, and assist BAC in the conduct of its functions among others.

This order takes effect immediately and shall remain in force until revoked.
