WHEREAS, the Department of Agriculture – Bureau of Agricultural Research through its Knowledge Management and Information System Division (KMISD) approved the Purchase Requests (PR) with reference number 2024-11-682 dated November 7, 2024, for the **Provision of Meals for the Conduct of DA-BAR's Sustainable Challenge Award (SCA) 2024** with an Approved Budget for the Contract (ABC) of **One Hundred Eight Thousand Pesos (₱108,000.00)**, inclusive of all applicable taxes and charges;

WHEREAS, out of the two (2) bidders who participated, **JOSTRELL'S BULALUHAN CORNER** was determined to have the **Lowest Calculated and Responsive Quotation (LCRQ)** with the total amount of **Ninety-One Thousand Three Hundred Ninety-Five Pesos (₱91,395.00)**, for the **Provision of Meals for the Conduct of DA-BAR's Sustainable Challenge Award (SCA) 2024**;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance of the participating supplier with the documentary requirements.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**:


