WHEREAS, the Department of Agriculture - Bureau of Agricultural Research through its Knowledge Management and Information System Division (KMISD) approved the Purchase Requests (PR) with reference number 2024-11-682 dated November 7, 2024, for the Provision of Meals for the Conduct of DA-BAR's Sustainable Challenge Award (SCA) 2024 with an Approved Budget for the Contract (ABC) of One Hundred Eight Thousand Pesos (\$108,000.00), inclusive of all applicable taxes and charges;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement under Section 53.9 - Small Value Procurement was advertised in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 11460250 dated November 12, 2024 with a deadline on November 15, 2024;

WHEREAS, out of the two (2) bidders who participated, JOSTRELL'S BULALUHAN CORNER was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of Ninety-One Thousand Three Hundred Ninety-Five Pesos (\$91,395.00), for the Provision of Meals for the Conduct of DA-BAR's Sustainable Challenge Award (SCA) 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance of the participating supplier with the documentary requirements.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE:
