WHEREAS, the Department of Agriculture – Bureau of Agricultural Research through its Administrative and Finance Division (AFD) approved the Purchase Requests (PR) with reference number 2024-11-687 dated November 11, 2024, for the Meals for DA-BAR Year End Culminating Activity with an Approved Budget for the Contract (ABC) of Sixty-Seven Thousand Nine Hundred Pesos (\$\mathbf{P}67,900.00)\$, inclusive of all applicable taxes and charges;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement under Section 53.9 - Small Value Procurement was advertised again in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 11488432 dated November 16, 2024 with a deadline on November 19, 2024;

WHEREAS, out of the two (2) bidders who participated, MAC KUSINA DE KAFE was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of Fifty-Nine Thousand Seven Hundred Fifty-Two Pesos (₱59,752.00), for the Meals for DA-BAR Year End Culminating Activity;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance of the participating supplier with the documentary requirements.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE:
