**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT  
TO ELEV8 TRADING AND MARKETING CORP. FOR THE PURCHASE OF CORPORATE

**WHEREAS**, the Bureau of Agricultural Research (BAR) is in need of a supplier to provide "Corporate vest for official use of BAR" with an Approved Budget for the Contract (ABC) of **₱299,000.00**;

**WHEREAS**, the mode of procurement shall be under **NP-53.9 - Small Value Procurement** and quotations shall be evaluated and awarded as **one (1) LOT**;

**WHEREAS**, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-08**, was posted/disseminated on January 15, 2024 with its deadline on January 22, 2024;

**WHEREAS**, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

**WHEREAS**, among the six (6) bidders who participated, **ELEV8 TRADING AND MARKETING CORP.** was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of **TWO HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED FIFTY PESOS (₱224,250.00)** for which the Bids and Awards Committee (BAC) decided to award the contract in the purchase of Corporate vest for official use of BAR";

**NOW THEREFORE**, for and in consideration of the foregoing premises, **WE**, the members of BAR-BAC, hereby **RECOMMEND** to the **BAR DIRECTOR** the awarding of contract requirements in favor of **ELEV8 TRADING AND MARKETING CORP.** in the purchase of Corporate vest for official use of BAR."




