**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-14**, was posted/disseminated on January 22, 2024 with its deadline on January 29, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, among the three (3) bidders who participated, **ATR MULTITRADE CONCEPT INC.** was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of **TWENTY TWO THOUSAND THREE HUNDRED THIRTY TWO PESOS (₱22,332.00)** for which the Bids and Awards Committee (BAC) decided to award the contract in the purchase of Certificate Holder for BAR use".
