BAC RESOLUTION RECOMMENDING THE CONTRACT TO CONCEPT AND INFORMATION GROUP, INC. FOR THE PUBLICATION OF AFFREDN IMPLEMENTING GUIDELINES

WHEREAS, the Bureau of Agricultural Research (BAR) is in need of a supplier to provide "Publication of AFFREDN Implementing Guidelines" with an Approved Budget for the Contract (ABC) of **₱240,000.00**;

WHEREAS, the mode of procurement shall be under **NP-53.9 - Small Value Procurement**, and quotations shall be evaluated and awarded as **one (1) LOT**;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-40**, was posted/disseminated on March 14, 2024, with its deadline on March 18, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, as the sole (1) bidder who participated, **CONCEPT AND INFORMATION GROUP, INC.** was determined to have the Single Calculated and Responsive Quotation (SCRQ) with the total amount of **THIRTY TWO THOUSAND EIGHT HUNDRED FIFTY-NINE PESOS & 20/100 (₱32,859.20)** for which the Bids and Awards Committee (BAC) decided to award the contract in the purchase of "Publication of AFFREDN Implementing Guidelines";

NOW THEREFORE, for and in consideration of the foregoing premises, **WE**, the members of BAR-BAC, hereby **RECOMMEND** to the **BAR DIRECTOR** for the award of the contract to **CONCEPT AND INFORMATION GROUP, INC.** for the "Publication of AFFREDN Implementing Guidelines";
