**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO GOLDDENN OFFICE AND SCHOOL SUPPLIES FOR THE PURCHASE OF PAPER SHREDDER FOR BAR OFFICE USE**

WHEREAS, the Bureau of Agricultural Research (BAR) is in need of a supplier to provide "Paper Shredder for BAR Office Use" with an Approved Budget for the Contract (ABC) of **₱330,000.00**;

WHEREAS, the mode of procurement shall be under **NP-53.9 - Small Value Procurement**, and quotations shall be evaluated and awarded as **one (1) LOT**;

WHEREAS an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-49**, was posted/disseminated on March 22, 2024, with its deadline on March 26, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, of the two (2) bidders who participated, **GOLDDENN OFFICE AND SCHOOL SUPPLIES** was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of **THREE HUNDRED NINETEEN THOUSAND PESOS (₱319,000.00)** for which the Bids and Awards Committee (BAC) decided to award the contract in the purchase of "Paper Shredder for BAR Office Use";

NOW THEREFORE, for and in consideration of the foregoing premises, **WE**, the members of BAR-BAC, hereby **RECOMMEND** to the **BAR DIRECTOR** for the award of the contract to **GOLDDENN OFFICE AND SCHOOL SUPPLIES** for the "Paper Shredder for BAR Office Use".






