

# CONTRACT AGREEMENT

RECEIVED

THIS AGREEMENT made on the 10 JUN 2025 20 between DEPARTMENT OF AGRICULTURE - BUREAU OF AGRICULTURAL RESEARCH (DA-BAR) of the Philippines (hereinafter called "**the Entity**") of the one part and **DCI INT'L I.T. SOLUTIONS & SERVICES CORP.** of Unit 3A Comtal L1-D1 Victoria's Place C. Raymundo Ave. Caniogan, Pasig City, (hereinafter called "**the Supplier/Service Provider**") of the other part;

WHEREAS, the **Entity** invited Bids for certain goods and ancillary services, particularly for the "**PROCUREMENT OF VARIOUS INKS, TONERS AND MAINTENANCE BOX FOR OFFICIAL USE OF DA-BAR AND DA-BPO**" under PR No. 2025-05-252 & 2025-04-192 and has accepted a Bid by **the Supplier** for the supply of those goods and services under Small Value Procurement in the sum of **ONE MILLION THREE HUNDRED NINETY-THREE THOUSAND SIX HUNDRED SIXTY PESOS (P1,393,660.00)**. (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - Request for Quotation;
  1. Schedule of Requirements;
  2. Technical Specifications; and
  3. Supplemental or Bid Bulletins, if any

3. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

4. Notice of Award of Contract; and the Bidder's *conforme* thereto; and
5. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


