**WHEREAS**, the Department of Agriculture – Bureau of Agricultural Research under the **Property and Supply Unit** of the **Ad-hoc Administrative and Finance Division** and **DA-BPO** allocated the amount of **ONE MILLION EIGHT HUNDRED SIX THOUSAND EIGHT HUNDRED SIXTY PESOS (P1,806,860.00)** as indicated in the approved Purchase Request No's. **2025-05-252** dated **May 5, 2025** and **2025-04-192** dated **March 26, 2025** and will be acquired pursuant to **Section 34 (Small Value Procurement)** of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009 and **awarding shall be done as (one) 1 lot.**




