**"RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF LOT 1 VARIOUS OFFICE EQUIPMENT AND LOT 2 2.0 HP AIRCONDITIONER SPLIT TYPE FOR OFFICIAL USE OF PDD, PMED, KMISD, CASHIER, OD, PSU, BMGUSU, PU & PMU OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 12009"**

WHEREAS, the Department of Agriculture – Bureau of Agricultural Research allocated the amount of **ONE MILLION ONE HUNDRED THOUSAND EIGHTY THREE PESOS (₱1,100,083.00)** as indicated in the approved Purchase Request No. **2025-04-214** dated **April 8, 2025** and will be acquired pursuant to **Section 34 (Small Value Procurement)** of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009 and **awarding shall be done as (one) 1 lot.**

WHEREAS, the BAC thru, its Secretariat, posted the Request for Quotation (Solicitation Number: **2025-101-50**) on **April 15, 2025** under Reference No. **11966489** at the Philippine Government Electronic Procurement System (PhilGEPS) with its deadline on **April 21, 2025** and **two (2) quotations were received.**

WHEREAS, of the **two (2) proposals** submitted and as per the approved Evaluation Report dated **April 28, 2025** submitted by the **Technical Working Group (TWG)** to the **Bids and Awards Committee (BAC)**, **NEW A.G. STYLIST FURNITURE** found to be **compliant for both offers to LOT 1 and LOT 2** as per submitted Request for Quotation together with the eligibility requirements while **APEX OFFICE SUPPLIES AND EQUIPMENT TRADING** found to be **compliant in LOT 1 and failed in LOT 2** due to no bid.

WHEREAS, **Section 42.1 of the IRR of RA 12009** mandates the BAC to i) recommend award of contracts to the HoPE or the duly authorized representative.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED recommend the following:






