WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement under NP-53.9 - Small Value Procurement was advertised in the Philippine Government Electronic Procurement System (PhilGEPS) under Reference No. 11103891 dated August 1, 2024 with its deadline on August 7, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidders/suppliers, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, among the three (3) bidders who participated, GAKKEN PHILIPPINES INC. was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of Four Hundred Twenty-Six Thousand Five Hundred Thirty-One Pesos (**P426,531.00*) for the Supply and Delivery of Heavy Duty Multifunction Printer (Standard Ink Package included);
