

CONTRACT AGREEMENT

THIS AGREEMENT made the ___ day of _____ 20___ between **DEPARTMENT OF AGRICULTURE - BUREAU OF AGRICULTURAL RESEARCH** of the Philippines (hereinafter called "the Entity") of the one part and **GAKKEN PHILIPPINES INC.** of 130 GPI BLDG., AURORA BLVD. COR. A LAKE ST., BRGY. SALAPAN, SAN JUAN CITY (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY AND DELIVERY OF HEAVY DUTY MULTIFUNCTION PRINTER (STANDARD INK PACKAGE INCLUDED** under **Solicitation No. 2024-101-105** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FOUR HUNDRED TWENTY-SIX THOUSAND FIVE HUNDRED THIRTY-ONE PESOS (Php426,531.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Technical Specifications;
 - ii. Notice of Award of Contract; and the Bidder's conforme thereto; and
3. In consideration for the sum of **FOUR HUNDRED TWENTY-SIX THOUSAND FIVE HUNDRED THIRTY-ONE PESOS (Php426,531.00)** or such other sums as may be ascertained, **GAKKEN PHILIPPINES INC.** agrees to **SUPPLY AND DELIVERY OF HEAVY DUTY MULTIFUNCTION PRINTER (STANDARD INK PACKAGE INCLUDED** under **Solicitation No. 2024-101-105** in accordance with his/her/its Bid.
4. The **DEPARTMENT OF AGRICULTURE - BUREAU OF AGRICULTURAL RESEARCH** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The **GAKKEN PHILIPPINES INC.**, agrees to complete and deliver within **Thirty (30) days** upon the receipt of Notice of Award of Contract (NOA) the following products offered in their submitted quotation (Proof of Product Offered):
 - a. 3 Units Epson Workforce Pro WF-C878R with one extra paper tray Multifunction Printer and standard ink package
6. The **GAKKEN PHILIPPINES INC.**, agrees to complete and deliver the products within the stated date. The said products must be delivered at the Bureau of Agricultural Research, in case of failure to make the delivery within the time specified, a penalty of one-tenth (1/10) of one percent for every day of delay shall be imposed on the undelivered items/s.


