**Recommendation on the Award of Contract for the Supply and Installation of
Window Blinds for BAR Building Use**

WHEREAS, the Department of Agriculture - Bureau of Agricultural Research through its management, approved the Purchase Requests (PR) with reference number 2024-10-623 dated October 7, 2024, for the **Supply and Installation of Window Blinds for BAR Building Use**, with an Approved Budget for the Contract (ABC) of **One Hundred One Thousand Nine Hundred Pesos (₱101,900.00)**, inclusive of all applicable taxes and charges;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement under **Section 53.9 - Small Value Procurement** was advertised in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 11375280 dated October 18, 2024 with a deadline on October 24, 2024;

WHEREAS, out of the two (2) bidders who participated, **ALBERCAS INTERIOR ENTERPRISE** was determined to have the **Lowest Calculated and Responsive Quotation (LCRQ)** with the total amount of **Sixty-Six Thousand Four Hundred Eighty-Two Pesos and 57/100 (₱66,482.57)** for the **Supply and Installation of Window Blinds for BAR Building Use**;

WHEREAS, upon review of the documentary requirements provided by the participating bidders/suppliers, the BAC Secretariat has determined the compliance of the participating supplier with the documentary requirements.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**:

- a) To declare the bid quotation of **ALBERCAS INTERIOR ENTERPRISE** for the **Supply and Installation of Window Blinds for BAR Building Use**, as the **Lowest Calculated and Responsive Quotation (LCRQ)**;
- b) To recommend to the Head of the Procuring Entity (HoPE) the awarding of contract requirements in favor of **ALBERCAS INTERIOR ENTERPRISE** for the **Supply and Installation of Window Blinds for BAR Building Use** in the total amount of **Sixty-Six Thousand Four Hundred Eighty-Two Pesos and 57/100 (₱66,482.57)**.


