WHEREAS, the Department of Agriculture – Bureau of Agricultural Research through its **Administrative and Finance Division (AFD)** approved the Purchase Requests (PR) with reference number **2024-11-687** dated **November 11, 2024**, for the **Meals for DA-BAR Year End Culminating Activity** with an Approved Budget for the Contract (ABC) of **Sixty-Seven Thousand Nine Hundred Pesos (₱67,900.00)**, inclusive of all applicable taxes and charges;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement under **Section 53.9 - Small Value Procurement** was advertised again in the Philippine Government Electronic Procurement System (PhilGEPS) with **Reference No. 11488432** dated **November 16, 2024** with a deadline on **November 19, 2024**;

WHEREAS, out of the two (2) bidders who participated, **MAC KUSINA DE KAFE** was determined to have the **Lowest Calculated and Responsive Quotation (LCRQ)** with the total amount of **Fifty-Nine Thousand Seven Hundred Fifty-Two Pesos (₱59,752.00)**, for the **Meals for DA-BAR Year End Culminating Activity**;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance of the participating supplier with the documentary requirements.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**:
