## BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO RIELOU GENERAL MERCHANDISE FOR THE PURCHASE OF CONSOLIDATED OFFICE SUPPLIES

WHEREAS, the Bureau of Agricultural Research (BAR) is in need of a supplier to provide "Consolidated Office Supplies" with an Approved Budget for the Contract (ABC) of \$\mathbb{P}142,000.00;

WHEREAS, the mode of procurement shall be under NP-53.9 - Small Value Procurement, and quotations shall be evaluated and awarded as one (1) LOT;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-33**, was posted/disseminated on March 1, 2024, with its deadline on March 8, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, among the three (3) bidders who participated, RIELOU GENERAL MERCHANDISE was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of ONE HUNDRED THIRTY SEVEN THOUSAND SEVEN HUNDRED SEVENTY PESOS (\$\mathbb{P}137,770.00) for which the Bids and Awards Committee (BAC) decided to award the contract in the purchase of "Consolidated of Office Supplies";

NOW THEREFORE, for and in consideration of the foregoing premises, WE, the members of BAR-BAC, hereby RECOMMEND to the BAR DIRECTOR for the award of the contract to RIELOU GENERAL MERCHANDISE in the purchase of "Consolidated Office Supplies";
