WHEREAS, the Bureau of Agricultural Research (BAR) is in need of a supplier to provide "Transportation services for the Conduct of 2024 BPO Annual Project Assessment on April 22-26, 2024" with an Approved Budget for the Contract (ABC) of ***78,500.00**;

WHEREAS, the mode of procurement shall be under NP-53.9 - Small Value Procurement, and quotations shall be evaluated and awarded as one (1) LOT;

WHEREAS an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-53**, was posted/disseminated on April 12, 2024, with its deadline on April 16, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, among the three (3) bidders who participated, GEOFFREY TRANSPORT SERVICE was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of SIXTY-SIX THOUSAND FIXTY SIX PESOS (\$\mathbb{P}66,056.00)\$ for which the Bids and Awards Committee (BAC) decided to award the contract in the provision of transportation services for the conduct of 2024 BPO Annual Project Assessment on April 22-26, 2024 ";

NOW THEREFORE, for and in consideration of the foregoing premises, **WE**, the members of BAR-BAC, hereby **RECOMMEND** to the **BAR DIRECTOR** for the award of the contract to **GEOFFREY TRANSPORT SERVICE** for the "Transportation services for the Conduct of 2024 BPO Annual Project Assessment on April 22-26, 2024".
