BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO MOSTACO MARKETING FOR THE SUPPLY AND DELIVERY OF OFFICE SUPPLIES

WHEREAS, the Bureau of Agricultural Research (BAR) is in need of a supplier to provide "Supply and Delivery of Office Supplies" with an Approved Budget for the Contract (ABC) of **₱143,095.00**;

WHEREAS, the mode of procurement shall be under **NP-53.9 - Small Value Procurement**, and quotations shall be evaluated and awarded as **one (1) LOT**;

WHEREAS an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement, with **Solicitation No. 2024-101-61**, was posted/disseminated on April 26, 2024, with its deadline on May 3, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidder/supplier, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, among the five (5) bidders who participated, **MOSTACO MARKETING** was determined to have the Lowest Calculated and Responsive Quotation (LCRQ) with the total amount of **ONE HUNDRED EIGHT THOUSAND FIVE HUNDRED EIGHTEEN PESOS (₱108,518.00)** for which the Bids and Awards Committee (BAC) decided to award the contract in the "Supply and Delivery of Office Supplies".

NOW THEREFORE, for and in consideration of the foregoing premises, **WE**, the members of BAR-BAC, hereby **RECOMMEND** to the **BAR DIRECTOR** for the award of the contract to **MOSTACO MARKETING** for the "Supply and Delivery of Office Supplies".


