RECOMMENDATION ON THE AWARD OF CONTRACT FOR THE ANNUAL SUPPLY (FOOD BASKET) FOR DA-BAR CY 2024

WHEREAS, the Department of Agriculture - Bureau of Agricultural Research (BAR) through the Administrative and Finance Division (AFD) allocated the amount of ONE MILLION EIGHT HUNDRED THIRTY-NINE THOUSAND SEVEN HUNDRED FORTY PESOS AND 56/100 (₱1,839,740.56) for the Annual Supply (Food Basket) for DA-BAR CY 2024 as indicated in the approved Purchase Requests (PR) with reference number 2024-10-592 dated October 1, 2024.

WHEREAS, Invitation to Bid was advertised in the Philippine Government Electronic Procurement System (PhilGEPS) under Reference No. **11341290** dated **October 10**, **2024** and in a conspicuous place within the office premises of the Department of Agriculture - Bureau of Agricultural Research for seven (7) days;

WHEREAS, a Notice of Postponement of Meeting was issued for the Pre-Bid Conference scheduled on October 18, 2024 due to the absence of a quorum from the Bids and Awards Committee (BAC);

WHEREAS, a Notice of Reschedule of Meeting was issued for the new schedule of Pre-Bid Conference on October 29, 2024, new schedule of Opening of Bids, Bid Evaluation and Post Qualification Review on November 18, 2024, November 19, 2024 and December 2, 2024.

WHEREAS, on October 29, 2024, a Pre-Bid Conference was conducted and Bid Bulletin No. 2024-18 was issued thereafter to clarify and/or amend the contents of the Invitation to Bid and Bidding Documents;

WHEREAS, in response to the abovementioned advertisement, a lone bidder appeared and submitted its bid proposal during the **Opening of Bids** on November 18, 2024 to wit:
