Recommendation on the Award of Contract for the Supply and Installation of Analok Aluminum Frame with Sliding Door

WHEREAS, the Department of Agriculture – Bureau of Agricultural Research through Building Maintenance, Security and General Utility Services Unit allocated the amount of Ninety-Two Thousand One Hundred Seventy-Three Pesos (₱92,173.00), for the Supply and Installation of Analok Aluminum Frame with Sliding Door as indicated in the approved Purchase Request No. 2024-07-422 dated July 3, 2024;

WHEREAS, an invitation to eligible bidders/suppliers to participate and submit quotations for the above requirement under NP-53.9 - Small Value Procurement was advertised in the Philippine Government Electronic Procurement System (PhilGEPS) under Reference No. 11036934 dated July 11, 2024 with its deadline on July 15, 2024;

WHEREAS, upon review of the documentary requirements provided by the participating bidders/suppliers, the BAC Secretariat has determined the compliance to documentary requirements of the participating supplier;

WHEREAS, between the two (2) bidders who participated, **CSN-J GLASS & ALUMINUM FABRICATION** was found to be the **Lowest Calculated and Responsive Quotation** with a total amount of **Eighty Thousand One Hundred Fifty Pesos (₱80,150.00)**;

WHEREAS, upon validation and verification of the submitted documentary requirements, **CSN-J GLASS & ALUMINUM FABRICATION** was found to be insufficient due to expired Business Permit and non-submission of Omnibus Sworn Statement;

WHEREAS, **JUAN CARLOS CONSTRUCTION SERVICES** was determined to have the **Second Lowest Calculated and Responsive Quotation (LCRQ)** with the total amount of **Eighty-Seven Thousand Three Hundred Twenty-Nine Pesos (₱87,329.00)** for the Supply and Installation of Analok Aluminum Frame with Sliding Door;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid quotation of **JUAN CARLOS CONSTRUCTION SERVICES** for the Supply and Installation of Analok Aluminum Frame with Sliding Door as the **Second Lowest Calculated and Responsive Quotation**;
- b) To recommend to the HoPE the awarding of contract requirements in favor of **JUAN CARLOS CONSTRUCTION SERVICES** for the Supply and Installation of
